#### 6. OBLIGATIONS OF THE CONTRACTOR

- a. The Contractor shall provide all labor, equipment, and supplies required to perform the services and undertakes to properly maintain all equipment so that work is performed timeously and to a professional standard.
- b. The Contractor shall carry insurance and have valid licenses as may be required by law to perform the services as outlined in this agreement.
- c. If the services cannot be carried out by the Contractor on any specified day, such service shall be re-scheduled as soon as possible by mutual agreement, failing which the cost of all missed services shall be deducted from the invoice.

#### 7. OBLIGATIONS OF THE CLIENT

- a. The Client need not be present during service calls and hereby grants permission to the Contractor and shall facilitate entry to access the property on scheduled or otherwise agreed service days during the local hours of 8 am to 7 pm.
- b. The Client shall be responsible for the removal of any objects e.g. toys, furniture, pet waste, rubbish, etc. that will hinder the Contractor in performing under this agreement.
- c. The Client shall keep all pets secured inside a building or fenced area and shall keep people away from the Contractor's area of work for the safety of all parties concerned whilst the Contractor is performing services.
- d. The Client shall notify the Contractor in writing of any plants that are particularly rare or are a collector's item and their approximate replacement costs. The Contractor reserves the right not to perform any services in close proximity to such plants.
- e. The Client shall be responsible for the day-to-day care of the lawn as recommended by the Contractor and which are not part of the services outlined here in the Agreement.

### 8. LIABILITY

- a. The Contractor shall not be liable be held liable for damage to items on or below the lawn surface which are not clearly visible or marked such as cables, wires, pipes, or sprinkler components.
- b. The Contractor shall be liable for damage caused to plants if such damage was caused by willful negligence or improper operation of equipment. Liability shall be limited to the replacement of the plant by the Contractor.
- c. The Client shall not be liable for any damage to the Contractor's equipment, or any injury or illness sustained by the Contractor and his/her employees or subcontractors or a third party in the performance of this service, and the Client shall not be indemnified against all claims arising from such damage, injury, or illness.
- d. The Contractor shall not be liable for the poor health or lack of performance of turf or plants beyond the scope of the service/s contracted for, or in any event where the Client does not provide appropriate or proper care for turf or plants.
- The Contractor shall be liable for any damage to the lawn or plants due to the incorrect application or choice
  of pesticides, herbicides, or fertilizers. Liability shall be limited to the replacement of the plant/s by the
  Contractor.



- **9. WHOLE AGREEMENT.** The Lawn Care Contract constitutes the sole and entire Agreement between the parties regarding the subject matter hereof and the parties waive the right to rely on any alleged expressed or implied provision not contained therein. Either party may terminate this Agreement in its entirety or amend the services provided such termination or amendment is made in writing and submitted to the other party 7 days before taking effect.
- **10. ASSIGNMENT.** No party may assign any of its rights or delegate or assign any of its obligations in terms of this Lawn Care Contract without the prior written consent of the other party.
- **11. GOVERNING LAW.** This Contract and Agreement shall be construed, interpreted, and governed under the laws of the Province of <u>Ontario</u>, and should any provision of this Contract be judged by an appropriate court as invalid; it shall not affect any of the remaining provisions whatsoever.
- **12. When will we service your lawn?** We offer lawn mowing services on both a weekly and biweekly basis. If your contract specifies weekly or biweekly service, we will attend to your lawn accordingly—either once a week or once every two weeks on the designated day. Our services commence between 8:30 am and 7:30 pm, with the precise timing influenced by weather and traffic conditions. We endeavor to complete our regular lawn mowing routes by 7:30 pm.
- **13. How often should I schedule lawn care services?** We recommend scheduling our services on a weekly basis for fast-growing lawns, or biweekly for slower-growing lawns, to ensure your lawn remains healthy and well-maintained.
- **14. Invoicing and Payments:** Invoices will be issued via email at the end of every 2-4 services, depending on the service frequency, allowing for monthly payment rather than weekly. You may conveniently pay or prepay your invoices using Visa or Mastercard online, or through **e-transfer** to **NatureRUsLandscaping@outlook.com**. Please ensure that you submit your signed contract along with the upfront payment at least five days before your next scheduled service.

**NOTE:** Payments made through Visa, Mastercard, Debit Cards, Apple Pay, Google Pay, and PayPal incur a transaction fee of 2.9% + \$0.30 or more. This fee will be added to your total payment if these methods are selected.

To proceed, both parties are requested to sign below to confirm their acceptance of the terms outlined in this contract. In the event that either party needs to terminate this agreement, a minimum notice of 24 hours is required. We aim to collaborate effectively to achieve a favorable outcome for all parties involved.
